The Swim & Tennis Club Birthday Party Registration Form

- Birthday parties are **\$375 for JCC members** of the Swim and Tennis Club and **\$430 for community members**. This cost includes swimming and access to the back porch for the duration of the party.
- A \$100 deposit is required at time of booking to reserve your date
- Birthday parties are **2-hours long**. If you would like additional time, extra time costs \$50 per half hour.
- The party fee allows for up to **15 children** participating in the activity. Additional children is \$8 per child.
- For parties with 20 or more kids, there will be an added charge of \$25 for additional staff
- 1 adult will be required to stay with children 8 years and under who are attending the party. There will be no charge for the adult.
- Guests are welcome to bring their own birthday party food snacks and dessert; we have refrigeration and freezers available if needed. We provide generic paper goods (cups/plates/napkins/utensils) and blue table clothes at no additional cost. Guests are welcome to bring their own decorations and paper goods if they want.
- Children are supervised in the pool by our certified lifeguard. All children 6-13 of age must pass a swim test to swim in sections where water is chest deep or over their head.
- For any child 5 and under using the large pool, an adult is required to be within arm's reach and in the pool. A \$5 fee will be charged for an adult required to be in the pool with their child. Children 5 and under using only the baby pool, there will be no additional fees.
- If birthday party is canceled due to inclement weather as decided by Swim & Tennis Club Director we will work to reschedule at a later date. If party is unable to schedule a full refund will be issued
- If birthday party is canceled due to host we ask for a 7 days' notice, we will refund partial paid, less \$75 administrator. There will be no refund for parties canceled 7 or less days prior.

Security Policies: The Mandell JCC is committed to the safety and security of all staff, members, students, and visitors on its properties. In order to support that commitment, the following guidelines have been developed and must be adhered to unless the JCC's Security Director has made an exception.

- Rosters will be required, listing all attendees (as well as speakers, performers, volunteers, vendors, etc.) in alphabetical order by last name.
 - Events that have issued tickets/passes, may substitute a roster if approved by JCC's Security Director.
- Positive ID is required of all attendees that are over 18 years of age. This must be communicated to all attendees in advance.
- No weapons of any kind may be carried on JCC property. This includes but is not limited to firearms, edged weapons, explosives, blunt weapons, handmade weapons, or anything designed to cause harm.
- No exterior doors may be propped open and left unattended without notifying prior permission from Security personnel
- No outside / private security personnel may be hired on JCC property without prior approval from the JCC Security Director.
- In the case that additional security measures or personnel are determined to be necessary, any incurred costs, including personnel, will be the sole responsibility of the person / group organizing the event.
- Additional security procedures may include, but are not limited to:
 - Clear bag and search policy, limiting size of bags allowed inside.
 - Pre-registration required and closes 24 hours prior to event time, in order to vet all names and do checks on unrecognized registrants.
 - Limiting or prohibiting open-source advertising of the location of your event until after one registers.
 - Local police department coverage
- To determine if special security measures are deemed necessary for your event, the Security Director will consider the following factors:
 - Affiliation with a religious organization
 - Events that cover controversial topics given the current environment
 - How widely and by what methods the event was publicized
 - A shift in the threat environment
 - The size of the event
 - The number of other programs/events occurring at the same time as the event
- Right to Evict: The JCC reserves the right to evict a group or any guest of the group, at any time, from its premises if deemed to have broken any of the facility rules, or if a group or its guest(s) has caused a disruption in the JCC's ability to provide a safe space for all guests and members using the facility.

I/We accept full responsibility for my/our use of any and all apparatus, appliances, facility privilege or services at my/our own risk. I/We shall indemnify and hold JCC harmless from and against all claims, actions, liabilities, damages and expenses, including litigation costs and reasonable attorney's fees, which may be imposed upon or incurred by me/us, in connection with loss of life, personal injury and/or property damage in consequence of or arising out of any occurrence at the Swim Club, occasioned wholly or in part by an act of omission of me/us, its agents, employees, participants, invitees or guests. JCC shall be entitled to recover all expenses and reasonable attorney's fees which it may incur in the enforcement of this Agreement. I/We agree to abide by the rules and regulations set forth by the Swim Club.
